C. Review, Discuss and take action on setting a Tentative Millage Rate for 2007-2008.

Council reviewed the various millage rates as instructed by City Manager Carrier. She advised Council of the effects that rolling back the millage rate could have on the city budget, such as closing the library, laying off staff, breaking the contract with the sheriff's office etc. If the super exemption was to pass in January then the city's budget would take another hit of \$100,000, which it simply cannot afford. Council could certainly lower the millage but to raise it again would take a city wide referendum, which is a very costly process. Staff recommendation is that the millage rate be dropped ½ mil (.50). City manager Carrier also suggested dropping it at the final hearing if council chooses to do so. She reminded Council to take in consideration that the staff employed by the city are also taxpayers and have not had a raise in 3 years. In fact, last year took a pay cut due to the rising cost of the health insurance. City Manager Carrier strongly feels that if we are not able to award increases this year, the city will lose very valuable people. Councilor McManigle asked what our millage rate was, City Manager Carrier stated that it was set a 6.7425 and by statute, the city is allowed to raise it up to 10.0000 mil. Council discussed the options and felt that it would be in the best interest of the city to keep the millage where it was right now. Mayor Penton expressed his concern since there are no reserve funds, in the event a hurricane or tornado was to come through the city, the city would virtually be bankrupt. The city never fully recovered from the 2004 Hurricanes due to FEMA and insurance not paying all the city was out expense wise.

Councilor Ames felt that "we simply cannot turn out the lights"; Mayor Penton strongly feels that the state had no right to implement what they did. Council came to a unanimous decision to keep the millage as is for now and hopefully once the growth Polk City is experiencing, shows up on the tax roll, perhaps they can lower the rate.

IV. CITY MANANGER ITEMS

- City Manager Carrier proposed to reserve August 8, 2007 at 7:00pm to hold a Budget Workshop. Council agreed to that date.
- City Manager Carrier reminded everyone of the Florida League of Cities Conference on August 16-18 2007 in Orlando.
- City Manager Carrier reviewed the calendar with council to make them aware of upcoming meetings.
- In addition, Mayor Penton will be sworn in as President of the Ridge League of Cities at the September Ridge League meeting and would like as many of council to attend as possible.
- Further, Council was asked about whether the city hall offices could close for a couple of days while moving in the new facility. Councilor Ames jokingly stated that there was always Saturday and Sunday available for moving.
- Sgt. Dan Cone offered the help of trustees with moving.
- The anticipated date to move into the new City Hall is late October to mid November barring something bad happening.
- City Manager Carrier reminded Council that a date needed to be set for the Lakeshore Residents Annexation Information Meeting. Council chose July 31, 2007 at 7:30pm.
- The generator for the New City Hall has been shipped; because the new city hall will also serve as an actual hurricane shelter having an emergency generator on site is a requirement.
- There are several grants in the works, Pam Peterson has been working on grants diligently, the most obvious is the SR 33 Beautification Project (CDBG grant) on the other side of the bridge.
- There is a meeting scheduled next week with the County Recreational Dept. to discuss the field next to the existing football field.
- City Manager Carrier met with C.C. Calhoun and Charlie Carnes today in regards to the Waste water treatment plant; they informed City Manager Carrier that they purchased the Thornall property. Some minimal mining will be conducted at this site to build a lake as the property will be developed. The appraisal was ordered and the city is moving forward with the sale. The engineers for the project are moving forward, and are 30% done with the Design Phase. They will be addressing Council soon, to show Council how everything is coming together.

Ms. Carrier suggested to maybe draw up a developer's agreement, that in the event the property was sold and it was zoned industrial at that time, the zoning would return to commercial. Ms. Carrier stated that she would look further into it.

Delilah McGill, a county resident, asked if Ms. Carrier could request the county to put speed humps in her neighborhood off Smith Rd. City Manager Carrier offered to facilitate a meeting with the county, but that would be all she could do since it is a county issue.

City Manager Carrier also requested to meet with the Smith Road residents to inform them of the progress of the Regional Waste Water Treatment plant and how it will affect their neighborhood. Ms. McGill suggested, she attend the neighborhood meeting the second Saturday of August. Ms. Carrier asked for Ms.McGill to please keep her informed as it draws nearer. Ms.Mcgill agreed to do so.
