### II. OTHER BUSINESS

A. REVIEW DISCUSS AND TAKE ACTION ON THE FIRST AMENDMENT TO THE MOUNT OLIVE SHORES IMPACT FEE CREDIT AGREEMENT.

Representatives of MOSN were present for this item. City Manager Carrier reviewed the Impact Fee Credit packet with Council. Staff is recommending an impact fee credit of \$74,162.49 to be split between the Water and Sewer Department. Vice Mayor Denico asked where this figure was coming from; City Manager Carrier directed her to Page 2 of the packet which gave the breakdown of upgrades requested by the city of the waterlines from an eight in. to a 10in , upgrades to the force main and the telemetric system. City Manager Carrier further explained that this figure is not actual money it is a credit to be used to offset any impact fees associated with pulling a permit for construction. There was no further discussion; Councilor Ames made a motion to accept the MOSN Impact Fee Credit Agreement; Councilor Adorno seconded the motion.

## B. REVIEW, DISCUSS AND TAKE ACTION ON THE PREANNEXATION AGREEMENT FOR JOSHUA LAND, LLC AND CC CALHOUN INC.

This is an annexation consists of sixteen different parcels totaling approximately 400 acres. The property lies north of town near Smith Road. It is known as "The Thornall" property. The owner is requesting a zoning of R-5, with a future land use of residential medium, in order to develop the property with upscale housing; the owner also envisions digging a lake for lake front homes. The owner is looking to build 50-75 large square footage homes on large lots. The first goal is to dig the lake; however, the digging will not take place until the construction of the Regional Wastewater Treatment Plant begins so that the dirt may be used for fill at the construction site. (This will be more costefficient than purchasing it from somewhere else). The annexation process will take approximately sixth months due to it being a large-scale amendment. (The total acreage is over ten acres and, therefore, is considered a large-scale amendment). Staff and the owner of the property have sat down together and have discussed using this property as the key to what is called a "District Annexation". A district annexation allows the city to bring in an additional fifteen parcels that are contigious, as long as it is unoccupied, raw land or has a zoning of commercial. City Manager Carrier assured Council, that before such an annexation is pursued a legal opinion will be sought to avoid any complications. Council did not have any further questions or comments. A motion was made by Councilor Ames to accept the pre-annexation agreement; Vice Mayor Denico seconded the motion.
