Mayor LaCascia read Ordinance 1271 in short title. City Attorney Cloud advised the Attorney from the Sheriff's Office asked the City to adopt this; the County has passed an ordinance as well. This will place a moratorium on any new pain management clinics until we know what the Legislature is going to do.

Ms. Shifflett then asked about utility rates – she had a question regarding the wording of a Resolution adopting rates; it stated the effective date being July 9<sup>th</sup>, and the rates were applied to the bill that went out July 10, 2010. After brief discussion, City Attorney Cloud advised it can be applied as it was, and there are current court cases whereby it is legal. Ms. Shifflett thinks it is wrong and doesn't agree with that; she feels people should be reimbursed.
