APRIL 1, 2014

Chairman Joe LaCascia called the meeting to order at 6:03 p.m.

Present: Mayor Joe LaCascia, Vice Mayor Mike Blethen, Councilor Don Kimsey, Councilor Keith Prestage, City Attorney Tom Cloud, City Manager Patricia Jackson and Assistant to the City Manager Sheandolen Dunn

Lori Edwards, Supervisor of Elections, advised the first order of business was to elect a Chairman for the Canvassing Board. Vice Mayor Blethen made a motion for Mayor LaCascia to preside as Chairman of the Canvassing Board; the motion was seconded by Councilor Prestage and unanimously carried.

Lori Edwards then went over the criteria of the Canvassing Board. There were 191 absentee ballots requested, and 133 of came back okay. At this time Ms. Edwards requested a motion to start processing the absentees. Councilor Prestage made a motion to start processing the absentee ballots; the motion was seconded by Vice Mayor Blethen and unanimously carried.

There are two absentee ballots to bring before the Canvassing Board whereby their signatures were not accepted by Patricia and/or Sheandolen because they did not appear to match what is on file. The absentee ballots were then reviewed by the Canvassing Board as follows:

- Voter ID Number E150806477 After review the Canvassing Board unanimously rejected this absentee ballot and Lori Edwards stamped the ballot "rejected."
- Voter ID Number E150742468 After review the Canvassing Board unanimously rejected this absentee ballot and Lori Edward stamped the ballot "rejected."

Chairman LaCascia then called a recess.

Chairman LaCascia then reconvened the Canvassing Board at 7:14 p.m.

There was one additional absentee ballot received to verify, and City Manager Jackson verified the signature. A motion was made, seconded and unanimously carried to accept the validation of the absentee ballot.

Chairman LaCascia called a recess at 7:15 p.m.

Chairman LaCascia reconvened the meeting at 8:01 p.m.

Lori Edwards advised three absentee ballots were refused by the machine, and the Canvassing Board needs to determine the voter's intent on each ballot as follows:

- 2) There was one area to check and the Canvassing Board determined the intent was a **yes** vote
- 3) There was one area to check and the Canvassing Board determined the intent was a **no** vote
