#### City-Initiated Text Amendment to the Polk City Comprehensive Plan

Proposed comprehensive plan amendment to add a Property Rights Element to the Comprehensive Plan to ensure that private property rights are considered in local decision making consistent with Florida Statutes 163.3177(6). The amendments include the creation of a Property Rights Element in the Comprehensive Plan.

Dana Riddell (CFRPC) provided a thorough explanation on the amendment adding the Property Rights Element.

Chairman Baker opened the Public Hearing; no one spoke for or against this Amendment; therefore, Chairman Baker closed the Public Hearing.

## **Land Development Code Amendments**

City-initiated text amendments to the Land Development Code to address inconsistencies.

Dana Riddell (CFRPC) provided a brief explanation on the amendment to the Land Development Code addressing inconsistencies that exists. These inconsistencies consist of changes such as changing "Council" to "Commission", "City of Polk City" to "Polk City". Very minor verbiage changes.
