#### ORDINANCE 2025-03

Stefanie Von-Pelaske-Bush provided an overview and PowerPoint for this Ordinance. An Ordinance of Polk City, Florida, amending the official Polk City Zoning Map to change to zoning on approximately 18.71 acres located at the northwest corner of Commonwealth Avenue (SR 33) and Citrus Grove Boulevard North from Planned Unit Development for 168 Multi-Family Units to Planned Unit Development to allow for 69 single-family dwelling units; providing for a Business Impact Estimate, severability, codification, repeal of conflicting ordinances, and an effective date. **First Reading** 

Attorney Hatcher-Bolin read this Ordinance by title only. Mayor LaCascia opened the Public Hearing. No one spoke for or against this Ordinance. Mayor LaCascia closed the Public Hearing.

Commissioner Blethen inquired about the removal of property taxes and what kind of impact would we see with the multi-family units versus the single-family homes.

Mayor LaCascia stated that this goes back to the state trying to gain more control over

the cities. Polk County taxes are 2% and we get approximately one-third of that.

Steve Sloan (Sloan Engineering, Bartow) spoke to clarify concerns regarding this project.

Commissioner Blethen expressed concerns about the maximum capacity at the school.

No further Discussion.

### ANALYSIS:

During the April 16, 2024 City Commission Meeting, the Commission voted to rescind the CDBG Grant Application packet for the Citrus Grove Boulevard Project, and to re-apply at a later date once the Environmental Assessment was completed, along with Construction Plans that were submitted by Chastain-Skillman.

We were notified that the new application cycle for FFY 24 is open and a completed CDBG Grant Application packet must be submitted by May 2, 2025.

Part of the application process is to hold two Public Hearing. The first Public Hearing will be held on April 15, 2025 (this meeting) and to obtain citizen comments concerning Polk City's economic and community development needs. The second Public Hearing must take place no later than Monday, April 28, 2025 to meet the application deadline of May 2, 2025.

#### **STAFF RECOMMENDATION:**

Continue with the Citrus Grove Boulevard Project (which is "shovel-ready") as previously approved by the City Commission.

#### CITY OF POLK CITY CDBG FIRST PUBLIC HEARING NOTICE

The City of Polk City is considering applying to the Florida Department of Economic Opportunity for a FFY 24 Small Cities Community Development Block Grant (CDBG) application. The City is eligible to apply for up to \$650,000 in the neighborhood revitalization, commercial revitalization and housing rehabilitation categories and up to \$1.5 million in the economic development category. Construction activities funded through the CDBG Program must meet one of the following National Objectives:

- 1. Provide benefit to low- and moderate-income persons;
- 2. Prevent or eliminate slum or blight conditions; or
- 3. Meet a need of recent origin having a particular urgency.

The types of activities that CDBG funds may be used for include constructing stormwater ponds, paving roads and sidewalks, installing sewer and water lines, building a community center or park, making improvements to a sewage treatment plant, and rehabilitating low-income homes. Additional information regarding the range of activities that could be funded will be provided at the public hearing.

In developing a CDBG application, Polk City must plan to minimize the displacement of persons as a result of the activities. In addition, Polk City is required to develop a plan to assist displaced persons.

A public hearing to obtain citizen comment concerning the City's economic and community development needs will be held at City Hall, 123 Broadway Blvd., SE, Polk City, FL on Tuesday, April 15, 2025, at 6:00 p.m. For information concerning the public hearing, please contact Patricia Jackson, City Manager, at (863)984-1375, ext. 237, or by email at Patricia.jackson@mypolkcity.org
