**CDBG Freedom Park Restrooms Project** – The restrooms should be complete by the end of this week.

**Water Line Repair** – City staff made repairs to a 6" water line.

**Budget** – The FY 2018-19 Budget will need to be in submitted to the City Commission by the end of July. The proposed Millage Rate has to be submitted by August 1. Once the budget is presented, a Workshop will be scheduled. The Commission will have a few weeks to review and address any concerns with the City Manager. A workshop will be scheduled in August prior to going into a Public Hearing. We are considering the exemptions as there will be an amendment on the ballot for the extra \$25,000 exemption which will affect the City in 2019, which is estimated at \$39,000. However, some of the homes that were not figured in came into Polk City did not come until late last year and will not hit the books until 2019.

**Christmas Parade** – Based on the new FDOT regulations, municipalities must get approval for the Christmas Parade. Therefore, staff is recommending approval of the Christmas Parade on December 1, 2018.

Motion by Commissioner Kimsey to approve the Christmas Parade scheduled for December 1, 2018; this motion was seconded by Vice Mayor Harris. Motion carried 4/0 by Voice vote.

City Manager Jackson responded the Budget will be done based on a millage rate of 7.4877. FDOT is moving towards roundabouts versus traffic lights. But, nothing is confirmed for Polk City to date. City officials must continue bringing this concern to FDOT's table.
