Executive Summary

The following points are presented as an overall summary of water and wastewater utility department activities and events that occurred during the month of March, 2012:

- Achieved all water and wastewater sampling and monitoring standards.
- Continuing work with GAI on all current projects.
- Working with the city on finalizing upcoming budget.
- Attended mandatory management training in Portland.
- August has involved juggling several large projects at the same time working with multiple different agencies.

Operations and Maintenance Activities

- Completed monthly compliance sampling.
- Continuing to repair and paint items and equipment as time permits.
- Adjusting wastewater facilities to accommodate lower summer flows and loadings.
- CommonWealth WTP well pump has been re-installed and is currently being flushed and prepped for the necessary clearance samples for the well to placed backed into service.
- Had a pump short out and electrical problems with lift station #1 on Brooks Ln. Currently have diesel bypass pump set-up as lift station back up. Currently waiting on more information from engineers before I can proceed with repair.
- Worked with contractors to repair sewer main break on Steven Rd.
- Worked with the city during the computer swap out.
- Delivered notice of start of construction to affected residents on Steven Rd.
- Have made additional adjustments to Matt Williams WTP to offset the CommonWealth well not being in service as a back-up.



- Had two water line repairs that required boil water notices to be delivered to affected customers. Water lines were repaired and clearance samples came back without any problems.
- Working with the city on readiness too serve charges.
- Have begun replacing bad curb stops as identified.
- Conducted monthly safety meetings for employees.
- Have worked with Empower Construction on the CDBG water line replacement project to minimize impact to customers.
- Continue working on SR 33 sprayfield to repair irrigation spray heads.

- o 43 locates;
- o 132 work orders completed.

September Activities:

- Finalize quote process to have the WTP Hydropneumatic tanks cleaned and resurfaced.
- Continue work on CDBG water project with Empower Construction and Odom Contracting.
- Continue working with Brandes Design on wastewater system upgrades.
- Have the CommonWealth well pump cleared and put back in service.
- Complete quarterly water quality sampling.
