EXECUTIVE SUMMARY

The following points are presented as an overall summary of water and wastewater utility department activities and events that occurred during the month of July, 2015:

- Completed company's monthly safety requirements.
- Valve representative came in and modified valves on Lakeland interconnect and set valves. Interconnect now works automatically as intended.
- Completed and submitted CCR delivery confirmation certifications to the department of health.
- Still working on re-surfacing of contact chamber.
- Continuing to replace the residential one inch meters for increased usage accuracy.
- Completed painting of the CommonWealth WTP.
- Working on painting of the other two water plants weather permitting.
- Working with city staff to complete budgeting process for upcoming year.

OPERATIONS AND MAINTENANCE ACTIVITIES

- Completed monthly compliance sampling.
- Attended management training course in Winter Garden.
- Re-sealed chlorine contact chamber and applied first coat of paint to interior of tank.
- Crane truck and Box truck were both repaired by Scott with the city.
- Third pump for future expansion of Voyles Loop has been repaired.
- Replaced TCU controller in Laynewade Liftstation.
- Had electrician re-wire gland seal leak detector to correct control issue with new pump at the Laynewade liftstation.
- Applied herbicide at storage lagoon at wastewater facility.
- Pressure washed all three water treatment plants.
