In August 2011, there were seven (7) PROCAP crimes reported compared to six (6) in August of 2010. A burglary to a business occurred at Ice Cream shop located at 205 Broadway Blvd. A petit theft occurred at 744 1st Street where scrape metal was stolen. There were no investigative leads developed in these cases.

Two Grand thefts occurred this month. One was at 733 4th Street where some jewelry was reported stolen. A family relative was a possible suspect. This case is being followed up by the P.C.S.O. Northwest Detectives. The second grand theft occurred at the Circle K Store located at 205 Commonwealth Ave. where an employee stole money from the store. She was arrested after the investigation.

A criminal mischief occurred at 606 Commonwealth Ave. at the Church of Christ where unknown suspects broke out some windows causing approximately \$200.00 in damage. A retail theft occurred at the Circle K Store located at 205 Commonwealth Ave. where a suspect stole two twelve packs of beer. The suspect was identified later by P.C.S.O. detectives and arrested.

A petit theft occurred at the city's scrape metal pile located on Bougainvillea Ave. where a suspect attempted to steal the scrape metal. City employees saw the theft occurring and contact the Sheriff's Office. Steven Connelly was arrested for the theft.
