In October 2012, there were seven (7) PROCAP captured crimes reported compared to eleven (11) in October 2011. Two business burglaries occurred during the month. One occurred at 411 Commonwealth Ave. at the Kirk & Riley Septic Service where unknown suspect entered the business and removed eight (8) semi truck batteries. The other occurred at 525 Commonwealth Ave. at the Ice House America self service ice vending machine where unknown suspects attempted to enter metal cover to remove the money.

Two grand thefts occurred during the month. One occurred at 533 Ashley Rd. where unknown suspect removed the screens from the windows to a vacant house. The other occurred at the Tire Store located at 111 Central Ave. where unknown suspect removed a set of tires from vehicle that was being repaired at the business.

A vehicle burglary occurred at the Van Fleet Trail Head where unknown suspect broke out a window to a vehicle and removed a duffel bag and purse. A retail theft occurred at the Dollar General Store at 125 Carter Rd. where unknown suspects removed merchandise from the store. A criminal Mischief occurred at 408 1st Street where a known suspect damaged property owned by the victim. An Austin Reeves was arrested for this offense.
