In April of 2013, there were six (6) PROCAP captured crimes reported as compared to five (5) in April of 2012. A conveyance burglary occurred at 456 Ashley Rd. where an unknown suspect entered an unsecure vehicle and removed a GPS system. A residential burglary occurred at 542 Citrus Grove Blvd. where an unknown suspect entered an unsecured residence but did not remove any property.

A grand theft occurred at 505 Orange Blvd. where unknown suspect removed a metal garbage dumpster that was along the side of the road. A petit theft occurred at 525 Commonwealth Ave. at the Chevron where an unknown suspect removed a wallet that was left by a customer from the front counter.

A burglary to a structure occurred at 111 Railroad Ave. where two known suspects removed an ATV, gas scooter, and two motorcycles. Both suspects were arrested. A criminal mischief occurred at 216 Trailview Way where a known suspect damaged the victim's front window. A complaint affidavit was filed with the State Attorney's Office.
