In March 2014 there were seven (7) PROCAP captured crimes as compared to six (6) in March of 2013. Two Petit thefts occurred during the month. One was at 635 1st Street where an unknown suspect stole a bicycle. The other occurred at 258 Sunset Blvd. where an unknown suspect removed fishing equipment from a boat.

A residential burglary occurred at 345 Honey Bee Lane where an unknown suspect entered the residence and removed a guitar and a 13 inch T.V. A grand theft occurred at the boat ramp to Lake Agnes where an unknown suspect removed 12 wooden fence posts. A Business burglary occurred at the Circle K Store where an unknown suspect kicked open the shed located in the rear of the store's property and removed several Styrofoam coolers, cups and plastic straws.

A criminal mischief occurred to a vehicle while it was traveling on Berkley rd. near Crape Myrtle Ln. Witnesses observed a suspect throwing items at the passing vehicle. The suspect was identified as Tyler Sowders and he was charged with criminal mischief.

A robbery occurred at 473 Honey Bee Lane where a known suspect grabbed the victim's purse while she was at his residence. The suspect refused to allow the victim to leave after he took her purse. The suspect was identified as Derrick Miller and he was arrested.

The unsolved cases have been assigned to Detective in the Northwest District for follow up investigation when further leads are developed.
