In April 2015, there were five (5) PROCAP captured crimes as compared to eight (8) in April 2014. Two Grand thefts occurred during the month. One was at 209 Greenleaf Ln. where unknown suspects removed a safe from the victim residence while the victim was showing the suspects a boat he had for sale. The second theft occurred at 122 Hydrangea Ave. where unknown suspect removed boat equipment and welding leads from an open field behind the residence.

A criminal Mischief occurred at 201 Citrus Grove Blvd. in the parking lot at Apt. 27 where an unknown suspect broke out three window to the victim's vehicle. A retail theft occurred at the Dollar General Market with an Allen Smith removed property from the store without paying for it. A complaint affidavit has been filed with the state attorney's office. A residential burglary occurred at 637 3rd Street where a Jason Ramsey entered the fenced in yard and damaged the skirting on the bottom of the residence. Ramsey was arrested at the scene.
