In April 2016 there were six (6) PROCAP captured crimes as compared to five (5) in April 2015. A vehicle theft occurred at the Ace Self Storage on Commonwealth Ave. where unknown suspects stole two four Wheelers. Two vehicle burglaries occurred during the month. One occurred at 116 V. Matt Williams Blvd. where an unknown suspect entered a vehicle and removed some vehicle parts from inside. The second occurred at Cattleman's Feed Store located on Commonwealth Ave. where an unknown suspect entered a vehicle and removed the stereo.

A residential burglary occurred at 1503 Barfield Rd. where an unknown suspect entered the victim's shed and removed a set of tires and wheels. A Grand Theft occurred at 201 Citrus Grove Blvd. where an unknown suspect removed two money orders valued over \$300.00 dollar from the residence. A retail theft occurred at the Circle K Store on Commonwealth Ave. where a known suspect took food items from the store and did not pay for them. A complaint affidavit was completed on the suspect. The other cases are being followed up by the Northwest Command Center General Crimes Unit.
