In May 2016, there were four (4) PROCAP captured crimes as compared to five (5) in May 2016. Three vehicle burglaries occurred during the month. One was at 130 Carter Blvd. where an unknown suspect removed cash from the victim's vehicle. The second occurred at the Circle K Store where a known suspect battered the victim while he was in his vehicle. The suspect left the scene and was charged by complaint affidavit. The third occurred at 456 Ashley Rd. where an unknown suspect entered the topper on the bed of a pickup truck and removed lawn equipment from inside.

A business burglary occurred at the Cattleman's Feed Store where a known suspect entered the business while it was closed and removed a check book from the office. The suspect was located and arrested. The unsolved case are being follow up by the Northwest General Crimes Unit of the Sheriff's Office.
