During this incident a utility trailer was stolen from All County Maintenance and welding located at 111 Central Ave, during this incident the suspects spray painted the surveillance cameras. There were two reported retail thefts. One case took place at the Circle K located at 205 Commonwealth Ave., and the second case was at 501 Commonwealth Ave. within 30 mins of each other. These two cases are related, and pose as a trend for Polk County and surrounding jurisdictions at this time. We are now sitting at -6% in crimes as compared to last year to date.
