### 2011 Polk City Year in Review (just a few of the highlights of a busy and successful 2011)

A lot has happened in Polk City over the last year. This is a good time to take a look back at 2010.

January 2011 –

- Polk City presented with a plaque in recognition of their efforts to revitalize Polk City by Sunshine Pharmacy
- Activity Center Fees decreased to \$100 plus tax for Polk City citizens.

#### February 2011

- Overview of the GAI report on Polk City Utilities "as is" reviewed with City Council
- Resolution 2011-01 Work began to prepare documents for Municipal Bonds for Polk City
- Blue Recycling Bins are distributed to Polk City citizens

#### March 2011

- Ordinance 1273 Mobile Homes
  - o Allow for mobile homes in the R-4 (mixed residential use) zoning district repealing all other ordinances passed
- Review and update of the Evaluation and Appraisal Report (EAR). A required planning report for all cities.
- Collection of Readiness to Serve charge was placed on the Property Tax Bill starting in 2011.

#### April 2011

- Water and Wastewater Optimization Plan/Financial Optimization/Revenue Sufficiency presented to City Council by GAI
- Council agreed to purchase Cardinal Hill Property

#### May 2011

- 2010 City Audit Review Auditor notes were half of what they were in 2009 and they continue to improve this year.
- Trudy Block received award for her work as Acting City Manager for the past year.

#### June 2011

• CDBG Grant awarded to Polk City for \$650,000 to replace water lines in the Railroad Heights area.

#### July 2011

• The yearly report for water quality was sent to all Polk City Utility customers. Polk City Utilities Drinking Water meets and/or exceeds ALL federal and state quality standards.

#### August 2011

• A Record Breaking Year for the Polk City Library Summer Program. 107 children signed up for the summer program September 2011

- Polk City was issued municipal bonds enabling Polk City to pay the debt owed to Polk County, restructure other debt and begin execution of plans to optimize Polk City Utilities.
- Standard and Poor (bond rating agency) gave Polk City an A- bond rating. The A- rating, with the addition of bond insurance, which brought Polk City's bond rating up to a AA rating, provided an advantage to Polk City in getting the lowest possible interest rate of 4.92% on the municipal bonds.

#### October 2011

- Polk City Budget completed for 2012
- Safe Haven Halloween was a huge success again this year with games and over 400 bags of candy distributed to the kids.
- Family Dollar Opens

#### November 2011

- Polk City had its first "Shop Polk City for Christmas" newsletter.
- Polk City Property Tax went down this year
- Dollar General Market begins construction
