- Ordinance 2013-1300, Amending the final budget, reallocating and re-appropriating monies within the budget for Fiscal Year 2012-2013. All other items in the Budget of Expenses to remain unchanged. Approved on first reading.

- Discussion and Acceptance of Painting and Repair to the Polk City Government Center. Approved Integrity Homes In the amount of \$7800.
- Appoint an Alternate Signee for City Bank Accounts Approved Councilor Trudy Block.
- Change Order #3 CDBG Water Line Replacement Project Approved Change Order #3 in the amount of \$5042 this was approved by Department of Economic Development - deficiencies in the pavement were discovered.
- Discussion and Acceptance to Purchase Mower approved purchase from Fields Equipment in the amount of \$7199.20.
- New Statute for Public Participation at Public Meetings presented by City Attorney; he will prepare a Resolution
- Motion made to begin the process for the City Manager Evaluation Motion tabled.
